Ngati Awa Relief Fund

The purpose of the Ngati Awa Relief Fund is to provide financial assistance for registered members of Ngāti Awa, in situations of serious hardship as a result of natural disasters within te rohe o Ngāti Awa.

Criteria for Funding Assistance

- Applicant must be registered on the Te Rūnanga o Ngāti Awa (Whakapapa) Register.
- The number of applications per household is limited to one per year (*Note 12 month stand down period from date of approval*).
- Proof of identity is required, e.g. Drivers Licence, Passport, or Community Services Card.
- Proof of address is required, e.g. Monthly invoice from a power or phone company.
- Te Rūnanga o Ngāti Awa staff are not eligible to apply.
